This double-sided adhesive tape consists of a water dispersible splittable paper carrier with a high cohesion water soluble modified acrylate adhesive on both faces. It has a good tack and excellent thermal resistance.

Special paper, splittable, repulpable

Siliconised paper on both sides, white, 60#

**Adhesive**

Repulpable acrylate, water soluble, clear

Ideal as a water repulpable splicing tape with high thermal resistance for core starting and roll closing.
