Product Description

ORALITE® 6900 Brilliant Grade are highly reflective, weatherproof, self-adhesive films with excellent corrosion and solvent resistance. The product was developed for the manufacture of vehicle livery markings and traffic signs.

ORALITE® 6900 sheeting is composed of a UV stabilized acrylic front film. Its retroreflective system consists of sealed cells of air backed microprisms, using total internal reflection. The distinct shape of the sealing pattern identifies the machine direction and the manufacturer of the sheeting shown in Figure 1.


Retroreflectivity

ORALITE® 6900 Brilliant Grade for Vehicle Livery complies with the UK Home Office Centre for Applied Science & Technology (CAST) (formerly PSDB) High Conspicuity Livery specification. The retroreflection values, shown in table 1 are complied with when measured in accordance with the corresponding specifications using CIE standard illuminant A, and the provisions of CIE No.54.2.

Colour

ORALITE® 6900 Brilliant Grade is available as white (010), fluorescent yellow-green (029), fluorescent orange (038), red (030), green (060) and royal blue (049). The sheeting conforms to the daytime colour requirements in tables 2 & 3 when measured in accordance with the provisions of CIE No. 15.2. The fluorescence luminance factors are given as informative values.

Adhesive

The adhesive consists of a solvent polyacrylate, permanent pressure sensitive adhesive specially formulated for the application onto metallic surfaces such as aluminium, zinc coated steel plate and painted metal surfaces. Application to non metallic surfaces should be tested and approved prior to full production. The adhesive is protected by a release liner made of polypropylene film, silicone coated on one side, 0.075 mm thickness.

Application/Processing

Surfaces to which ORALITE 6900 Brilliant Grade will be applied must be thoroughly cleaned from dust, grease or any contamination which could affect the adhesion of the material. Freshly lacquered or painted surfaces should be completely cured. The compatibility of selected lacquers and paints should be tested by the user, prior to application of the material. For other applications the user is fully responsible for evaluating the suitability of the product, and for any risks associated with that use. For detailed application instructions and for applications requiring edges to be sealed please refer to the appropriate documentation or contact your ORAFOL Reflective Solutions Division representative for advice.

Orientation

ORALITE® 6900 Brilliant Grade will perform effectively at either 0° or 90° orientations allowing for the most efficient use of the material. In cases where individual pieces are aligned adjacent to others, text combined with panels and or striping, it is recommended to utilise the material in the same orientation.
